SECTION I - THE SCHEDULE

1.0 DESCRIPTION:

The American General Consulate Frankfurt plans to seal a house wall in Giessener Strasse 30 / Consular Office Building (COB), which becomes permeable to water when there is heavy rain.

2.0 TYPE OF CONTRACT

This Solicitation will result in a firm fixed-price order.

3.0 PRICING

Pricing is to be provided for the services as stated on the Pricing Schedule, Attachment 'A', and shall include all labor, materials, general and administrative expenses (G&A), and profit. Any costs not priced will be considered to be included in the overhead and other indirect costs.

4.0 PERFORMANCE / DELIVERABLES

4.1 Period of Performance - The Contractor shall be required to (a) commence on-site construction work under this contract within 5 days after the issuance date of the "Notice To Proceed" (NTP), (b) prosecute the work diligently, and (c) complete the entire construction work ready for use not later than 60 calendar days after the issuance date of the NTP. The time stated includes the time for final cleanup of the premises, completion of punch-list items and all other items specified in the contract.

4.1 Site Survey - All offerors are required to examine the building D-Wing conditions before submitting an offer. The American Consulate General Frankfurt, Germany will provide professional support and conduct a quality control on completion of the work.

4.3 Government Point of Contact - Contact details of the the Government Point of Contact (POC) for coordinating these services will be provided at time of award.

5.0 STATEMENT OF WORK (SOW)

- Most work has to be carried out at weekends, hence restarting of the KV boxes and interior current distribution must be ensured by Sunday evening at the latest.

- Building site, building site equipment and KV boxes must be secured to ensure daily processes of the Consulate are not disrupted.
- Staff working in the Consulate will be subjected to a background check.
- Work must be carried out without current connection, except for the final inspection.
- Electricians who execute work on the switching stations must provide proof of training on the switching stations of Siemens.
- If the contractor identifies damages or any inoperative electrical components during the work carried out, this must be notified to the client immediately.
- Access to required utilities, water and electricity, will be provided by the U.S.G.

Please note: The contractor must determine with the POC which parts of the D-Wing will be de-energized before work starts.

5.1 General Work

- a. Remove topsoil and store at the side.
- b. Manual excavation in the section of KV boxes and cable inlet to the building.
- c. De-energization of KV boxes and cables, confirm all-poles are de-energized.
- d. Check with the client which parts of the D-Wing will be de-energized before work starts.
- e. Secure positioning of KV boxes including concrete base frame, repair any damages.
- f. Prepare, clean wall surface, remove loose plastering and fill in accordingly.
- g. Sealing via bituminous thick film coating or bituminous sheeting.
- h. Protection of sealing via dimpled sheeting.
- i. Backfilling in layers manually or, where possible, also with a digger.
- j. Foundation for KV boxes.
- k. Gravel belts and edging stones to avoid moisture around the KV boxes.
- l. Reconnect mains voltage to KV boxes.
- m. Since most work has to be carried out at weekends, restarting of the KV boxes and interior current distribution must be ensured by Sunday evening at the latest.
- n. Building site, building site equipment and KV boxes must be secured to ensure daily processes of the Consulate are not disrupted.
- o. Staff working in the Consulate will be subjected to a background check.
- p. Commissioning must be performed in accordance with VDE 0100.
- q. Work must be carried out without current connection, except for the final inspection.
- r. Electricians who execute work on the switching stations must have carried out training on the switching stations of Siemens.
- s. If the contractor identifies damages or any inoperative electrical components during the work carried out, this must be notified to the client immediately.
- t. Rough dimensions for the pad should be minimum 4m+0.75m+0.50m. As sub-base 30cm gravel. Thickness of concrete C25/30.
- u. Identification of the Bituminous film should be SporoThene Best. Nr. 878 or equal.

5.2 Asbestos-Containing Materials Restriction

Asbestos-free materials shall be used. The Government reserves the right, at no additional cost to the Government, to disapprove and to disallow the installation of any item containing asbestos.

5.3 Safety

- a. The contractor must ensure a working environment and process which protects the public as well as staff, property, material consumables, and facilities of the U.S. Government which are exposed to the work of the contractor
- b. The contractor must avoid interruptions in government work and any delays in completion deadlines of the projects, and monitor the costs for execution of the contract.
- c. All work is to be executed in accordance with relevant local, state and federal safety standards in Germany

as well as the U.S. Army Corps of Engineer Safety and Health Requirements Manual EM 385-1-1, whereby the strictest standard is to be applied accordingly. This document is available under http://www.publications.usace.army.mil/Portals/76/Publications/EngineerManuals/EM_385-1-1.pdf

- d. The contractor must observe the standards prescribed by the local authority responsible for health and safety at the workplace.
- e. The contractor must ensure that all additional measures are taken which the awarding authority prescribes as reasonable and appropriate for this purpose.
- f. The contractor must specify a contact person responsible for all safety issues on site. This person must be available at all times during work, either by phone or personally. The designated safety contact person must visit and inspect the place of work. If the contact person is not on site, a foreman or supervisor must be specified who is responsible for all safety issues for the general contractor as well as for each subcontractor working on site.
- g. The name of the company, the safety office and the contact person of the U.S. Consulate including telephone numbers are to be specified on a signboard (plastic-laminated or similarly prepared) and fixed at the entrance to the building during all working hours.
- h. Provisional cabling, use of portable electrical devices or other recognized electrical danger sources - provisional cabling and portable electrical devices must be used with a residual current circuit breaker (RCCB) in the respective electrical circuits; other electrical sources of danger may also require a RCCB;
- i. Hazardous substances – materials with physical or health risk, corrosive, toxic, reactive or instable materials, as well as any work which causes contamination of any kind within a building used by persons, such as dust from demolition work, paints and lacquers, solvents etc. When using hazardous substances or executing work which may lead to hazardous conditions, a control plan must be submitted to the POC and approved by the POC accordingly.
- j. Dangerous noise level: the workplace is an office building. The contractor will take all precautions to reduce the noise level caused by normal work. All unusually loud work is to be coordinated in advance with the POC and may require a time regulation or may have to be carried out alternately. Appropriate hearing protection is to be worn at all times, depending on the respective task.
- k. The contractor must provide a first aid box on site.
- l. Appropriate personal protective equipment (PPE) must be worn at all times. This includes appropriate footwear, clothing, eye protection, gloves etc. Safety helmets must be worn when executing work overhead.
- m. All important safety signs, barriers, signal lamps etc. are to be prepared and installed by the contractor.
- n. The contractor must also assert such requirements with his suppliers and sub-contractors.
- o. Work must never be carried out on circuits which are live. All work on electrical circuits must be executed in accordance with EM 385-1-1, and the Electrical Safework Practices-Post Lockout/Tagout Policy (LOTO), Attachment 'B' processes for maintenance safety must be observed.
- p. All hot work (welding, flame cutting, plasma arc cutting) must be examined in advance together with the POC and approved by the POC accordingly. Appropriate safety precautions (fire extinguishers, fire guard) are the responsibility of the contractor.

6.0 PAYMENT

The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights--

The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience*. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause*. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty*. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

The Contractor shall at all times keep the work area, including storage areas, free from accumulations of waste materials. Before completing the work, the Contractor shall remove from the work and premises any rubbish, tools, scaffolding, equipment, and materials that are not the property of the Government. Upon completing the work, the Contractor shall leave the work area in a clean, neat, and orderly condition satisfactory to the Contracting Officer.

(End of clause)

52.246-21 Warranty of Construction (Mar 1994)

- (a) In addition to any other warranties in this contract, the Contractor warrants, except as provided in paragraph (i) of this clause, that work performed under this contract conforms to the contract requirements and is free of any defect in equipment, material, or design furnished, or workmanship performed by the Contractor or any subcontractor or supplier at any tier.
- (b) This warranty shall continue for a period of 1 year from the date of final acceptance of the work. If the Government takes possession of any part of the work before final acceptance, this warranty shall continue for a period of 1 year from the date the Government takes possession.
- (c) The Contractor shall remedy at the Contractor's expense any failure to conform, or any defect. In addition, the Contractor shall remedy at the Contractor's expense any damage to Government-owned or controlled real or personal property, when that damage is the result of--
- (1) The Contractor's failure to conform to contract requirements; or
 - (2) Any defect of equipment, material, workmanship, or design furnished.
- (d) The Contractor shall restore any work damaged in fulfilling the terms and conditions of this clause. The Contractor's warranty with respect to work repaired or replaced will run for 1 year from the date of repair or replacement.
- (e) The Contracting Officer shall notify the Contractor, in writing, within a reasonable time after the discovery of any failure, defect, or damage.
- (f) If the Contractor fails to remedy any failure, defect, or damage within a reasonable time after receipt of notice, the Government shall have the right to replace, repair, or otherwise remedy the failure, defect, or damage at the Contractor's expense.
- (g) With respect to all warranties, express or implied, from subcontractors, manufacturers, or suppliers for work performed and materials furnished under this contract, the Contractor shall--
- (1) Obtain all warranties that would be given in normal commercial practice;
 - (2) Require all warranties to be executed, in writing, for the benefit of the Government, if directed by the Contracting Officer; and
 - (3) Enforce all warranties for the benefit of the Government, if directed by the Contracting Officer.
- (h) In the event the Contractor's warranty under paragraph (b) of this clause has expired, the Government may bring suit at its expense to enforce a subcontractor's, manufacturer's, or supplier's warranty.
-

(i) Unless a defect is caused by the negligence of the Contractor or subcontractor or supplier at any tier, the Contractor shall not be liable for the repair of any defects of material or design furnished by the Government nor for the repair of any damage that results from any defect in Government-furnished material or design.

(j) This warranty shall not limit the Government's rights under the Inspection and Acceptance clause of this contract with respect to latent defects, gross mistakes, or fraud.

(2) Was convicted of a felony criminal violation under any Federal law within the preceding 24 months, where the awarding agency is aware of the conviction, unless an agency has considered suspension or debarment of the corporation and made a determination that this action is not necessary to protect the interests of the Government.

(b) The Offeror represents that--

(a) *North American Industry Classification System (NAICS) code and small business size standard.* The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). (a) *Definitions.* As used in this provision--

"Forced or indentured child labor" means all work or service--

"Highest-level owner" means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

"Immediate owner" means an entity, other than the offeror, that has direct control of the offeror. - (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Predecessor" means an entity that is replaced by a successor and includes any predecessors of the predecessor.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

"Sensitive technology"--

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically--

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

"Service-disabled veteran-owned small business concern"--

(1) Means a small business concern--

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern" means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

"Small disadvantaged business concern", consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that--

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by--

"Subsidiary" means an entity in which more than 50 percent of the entity is owned--
