**VISA COURIER SERVICES** for the General Services Office at the U.S. Embassy Berlin, Germany. Interested offerors shall review the attached pages of this solicitation and submit offers accordingly.

**Synopsis:**

This is a combined synopsis/solicitation for commercial item services prepared in accordance with the format in FAR Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; offers are being requested and a written solicitation will not be issued.

The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular FAC 2005-89, dated July 14, 2016.

**Contract Type:**

The Government intends to award a firm fixed price commercial items service contract based upon the lowest priced, technically acceptable offer which conforms to the solicitation.

**Question Submission:**

Interested offerors must submit any questions concerning the solicitation within 3 days after issuance of this notice, to the POC's email address. Questions not received within this time period will not be considered.

**Delivery and Acceptance:**

Performance of the services: shall take place in Berlin, Germany.

SECTION I THE SCHEDULE

---

**1. The Contractor shall provide Visa Courier Services to the GSO Travel & Visitors Unit at the US Embassy Berlin, Germany.**

**2. Contract Type:**

The Government intends to award a firm fixed price Commercial Items Service Contract with 1 base year and 4 option years.

**3. Statement of Work:**

Contractor acts as liaison between the U.S. embassy Travel & Visitors Unit (TVU) and the foreign embassies located in Berlin.

Expected average amount of trips to different foreign embassies per day: 6 to 10

Average amount of passports (visa requests) to be processed per month: 220

Most visited Embassies per year: Israel, Cameroon, Nigeria, Ghana, Uganda, Gabon, Azerbaijan, Burkina Faso, Turkey, Algeria, Mali.

**Following services shall be provided:**

1. Pick up daily between 8:30-9:00 hrs the passports and all related documentation including Note Verbales from the Travel & Visitors Unit (TVU) office in Mitte.
2. Check that all paperwork is correct (application forms, pictures, etc.) and Note Verbales match the standard requested by the respective foreign embassies.
3. Deliver to the foreign embassies on the same day.
4. Inform TVU immediately via telephone if the foreign embassy does not accept the paperwork because of previously unknown changes to their requirements and return paperwork to TVU on the same day for correction/addition, etc.
5. Follow up with the foreign embassies to check when visas are ready.
6. Keep track of the deadlines when passport needs to be returned to traveler for an upcoming trip and inform TVU if a deadline cannot be met and visa issuance is delayed.
7. Pick up passports from the foreign embassies and return to TVU on the same day before 15:00 hrs.
8. If more than one visa is needed for the same passport, automatically pick up the passport at one foreign embassy and deliver it to the next one, if possible on the same day.
9. At all times keep TVU informed on the status of a visa request and the whereabouts of the passport.
10. Inform TVU via e-mail or in person within 24-hours about changes of visa requirements and provide a copy of the new application form, i.e. the correct link if only available online.
11. Inform TVU via e-mail or in person within 24-hours changes of foreign embassies locations, opening hours and/or upcoming holidays.

**The Contractor is required to:**

1. Have enough employees to be able to provide the service. Minimum of 3 couriers/drivers is requested.
2. Have enough vehicles in the fleet to be able to drop off and pick up the passports every day at all foreign embassies. Minimum of 3 vehicles is requested.
3. Identify one courier among the staff that shall have access to the TVU office inside the U.S Embassy. Incumbent must be able to pass the security clearance in order to receive an Embassy badge.
4. Know that all couriers delivering to the foreign embassies will act as representative of the U.S. Embassy and therefore need to perform accordingly. It should be noted that many foreign Embassies require that only one and the same courier submit paperwork to them. The U.S. Embassy will provide, if needed, a letter of introduction for the courier to present to the foreign embassy.
5. Guarantee no interruption of service during normal operating hours of TVU and of the foreign embassies.
6. Have at least 5 years of experience with providing visa services as proof for good working relations with all foreign embassies in order to expedite, whenever possible, visa requests.
7. Know the location, opening hours, waiting time and respective holidays of all foreign embassies, i.e. their consular sections, in order to lay out an optimal route and be able to deliver all passports on the same day.
8. Know the visa requirements for U.S. diplomatic and official passports holders for each foreign country to be able to inform TVU of any change.
9. Advance visa fees (at no extra cost) when necessary and in accordance with TVU instructions when the application is submitted to the foreign embassy and submit the invoice to TVU for reimbursement of the visa fee.
10. Do the utmost to meet the deadline for issuance of a visa knowing that requests are often short notice.

- 11. Act promptly when passports are ready to be picked up.
- 12. Know that certain foreign embassies require more than one trip before passport & visa is ready for pick up, but only one trip (transportation) to deliver and one for pick up is charged to the U.S. Embassy.
- 13. Submit a monthly invoice to TVU which lists each day:
  - a) The individual traveler's name (i.e. passport's holder)
  - b) The name of the foreign embassy visited

**4. Delivery (Period of Performance):**

The contract will be for a period of one year, with a maximum of four one year optional periods of performance and will commence on execution of the contract by signature of the Contracting Officer.

**5. Pricing:**

Prices are to be provided for the line items as stated on the Price Schedule, Attachment 'A'

**6. Payment :**

Payment will be made via Electronic Fund Transfer (EFT) in accordance with Federal Acquisition Regulation FAR 32.9 "Prompt Payment". Invoice remittance details will be provided in the contract at time of award.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Predecessor" means an entity that is replaced by a successor and includes any predecessors of the predecessor.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

The term "successor" does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.
